HCLA's CCHC members provide health care to the most underserved within the county including Seniors and People with Disabilities The IPA provides a vehicle for these CCHC's to contract with Health Plans to serve Managed Care Patients including Commercial, Covered California, Medi-Cal, Medicare and Cal Medi-Connect product lines.
