Interpreta Data

2021 Interpreta data will be available in March after the 2020 HEDIS rules are certified and loaded into the system. However, you may notice that there are measures for CBP, WCV and W30 that have "INT" after them. This identifies an

Interpreta temporary measure until the final rules are confirmed and data is available for these measures.

Interpreta member gap reports are the best tool to use to start the year and bring in your patients who missed their screenings and chronic care last year. Data in the portal reflects those members who are still due in 2020/2021. Please also start early to schedule seniors for their Annual Wellness Visits and to complete missing multi-year measures such as Breast Cancer Screenings and Cervical Cancer Screenings. Alignment – Alignment Health Plan is offering a free patient satisfaction training for the providers in their network entitled "Leading to a Positive Patient Experience" on Thursday, February 4, 2021, at 12:00 p.m. Please email Stars@ahcusa.com to request the link to the training and obtain more information.

COVID Vaccination Tracking – The COVIDReadi system (COVID–19 Vaccination Provider Registration System administered by the California Department of Public Health) is open for registration at https://ca.covidreadi.com/. All Health Care Providers who receive and administer COVID–19 vaccines must be enrolled in the program and have a valid CAIR2 Org Code. For further information on DHCS COVID–19 vaccine administration, please go to DHCS COVID–19 Vaccine Administration FAQs.

DHCS Extension - DHCS received approval from the Centers for Medicare & Medicaid Services (CMS) for a one-year extension of the Medi-Cal 2020 Section 1115 demonstration, through December 31, 2021. Programs include, but are not limited to, the Global Payment Program (GPP), Whole Person Care (WPC), transition of the Medi-Cal pharmacy benefit from managed care to feefor-service, the Dental Transformation Initiative (DTI), and Drug Medi-Cal Organized Delivery Systems. Additional updates are posted on the DHCS COVID-19 resource page.

New Telehealth CAHPS Survey – The Agency for Healthcare Research and Quality (AHRQ) has released a new Clinician & Group Visit Survey 4.0 that addresses telehealth visits by asking if the visit was by phone or video. This can be used to as a guide when designing your own patient satisfaction surveys for your patients. Blue Shield - On January 1, 2021, Blue Shield Promise's Medicare membership was officially transferred to Blue Shield of California. As a result, Blue Shield Promise no longer offers Medicare Advantage plans and Blue Shield Promise Medicare Advantage plan enrollees have transitioned over to Blue Shield of California Medicare Advantage plan.

2021 MCAS Measures - The final 2021 MCAS (Medi-Cal Managed Care Accountability Set) measures have been released by DHCS (Department of Managed Health Care) and are included with this newsletter. MCAS is a set of performances measures that DHCS selects for annual reporting by Medi-Cal managed care health plans. For 2021, pharmacy-dependent measures were removed because of the Medi-Cal Rx transition but they may reappear in MY2022.
